

NURSE AIDE REFRESHER COURSE INFORMATION

Beginning in June 2002, the West Virginia Nurse Aide Training and Competency Evaluation Program began offering an alternative way to re-register as a nurse aide in West Virginia. If, as a registered nurse aide in West Virginia, you were denied registry status due to the lack of/or inability to fulfill the Federal requirement of working for monetary compensation for eight (8) hours every twenty-four months since placement on the registry or if you failed to re-register within the past five (5) years, you may be eligible to participate in this alternative re-registration.

In order to be eligible, you must answer **NO** to all of the following questions:

1. Are you on the West Virginia Nurse Aide Abuse Registry?
2. Do you currently have an abuse allegation pending with the West Virginia Nurse Aide Program?
3. Are you listed on an abuse registry in another state?
4. Have you been convicted of a crime against a child the elderly or an incapacitated adult?
5. Has your registration been lapsed **OVER** five years?

If you have answered **no** to all of these questions, and are interested in being placed on the West Virginia Nurse Aide Registry, please read the following procedures for the Nurse Aide Refresher Course and state approved Nurse Aide Competency Evaluation that follows.

**PROCEDURE FOR THE NURSE AIDE REFRESHER COURSE
AND
STATE APPROVED COMPETENCY EVALUATION**

The nurse aide refresher course is designed to prepare eligible nurse aides to take the State Approved Competency Exam instead of taking a complete education program. The refresher course is a review of the curriculum covered in an approved nurse-aide training program and includes the opportunity to practice and review the skills required of a long-term care nurse aide. The course is a minimum of eight (8) hours, but may be longer. The refresher course is being offered by long-term care facilities, vocational schools and in-service providers throughout the state and the length and cost of the course varies. A list of the providers follows. After you have completed the refresher course you will be eligible to take the state approved written and skills test to place your name back on the West Virginia Nurse Aide Registry.

DO NOT CONTACT THE NURSE AIDE REGISTRY TO REGISTER FOR THE REFRESHER COURSE OR TO RETEST. YOU MUST CONTACT ONE OF THE PROVIDERS ON THE LIST.

The refresher course provider you contact will follow an approved curriculum to assist you in preparation for the state test. The refresher course is a review. The skills checklist used in approved nurse aide training programs will be given to you to allow you to review the skills list and practice any of the listed skills you feel may be your weak area(s). The refresher course should allow time to practice in a skills lab setting. **You may not practice skills using residents.**

Before the candidate can begin the refresher course, the candidate must:

- Present a photo identification card or driver's license to the facility administering the course. You must also give the name under which you were previously registered.
- Be verified as eligible for the refresher course through the on-line system at the web site: www.wvdhhr.org/ohflac

After the course is completed, the candidate will be able to take the state approved test. **The Nurse Aide Refresher Course provider** will fax or mail the Application for West Virginia Nurse Aide Evaluation and the Completion of Refresher Course to indicate you are ready to take the state approved test to:

PHD will also verify each submitted candidate's eligibility prior to issuing an admission ticket for testing. You will not be allowed to work until you have passed the state approved skills and written test and those scores have been turned in to the West Virginia Nurse Aide Registry (typically about two weeks after you take the state approved test). You will not be classified as test eligible on the nurse aide registry. Your status will remain inactive until you have passed both portions of the state approved test. Do not mail the application to test to the Nurse Aide Registry office; it should be mailed directly to PHD, along with the proper fee. PHD accepts money orders, certified checks, and facility checks only.

Other restrictions:

- You must apply to take the state approved test within sixty (60) days of completion of the nurse aide refresher course.
- You will have three (3) opportunities to pass the state approved test within six months. If you fail any portion or both portions of the test in three attempts, you will be required to complete an approved Nurse Aide Training Program.
- You must make sure that the facility is aware of any name under which you were previously registered—it must also be submitted to PHD.

This is a voluntary program. The refresher course provider has the option of charging a fee for this program. The facility or training program **will not** be required to pay for testing fees. All fees are the total responsibility of the eligible nurse aides.
